# ECOVISION SHORT FILM COMPETITION DOCUMENTARY EDITION

Epson Philippines Corporation in partnership with the DENR – Environmental Management Bureau – Environmental Education and Information Division (DENR-EMB-EEID) conduct the second installation of the Epson EcoVision Short Film Competition (Documentary Edition), which aims to tap the artistry of the Filipino students to raise public understanding of the environment and its conservation through short documentaries.

#### **Qualifications:**

- Individual or group entrants (including all production team members) must be bona fide students, at any year level and degree or course, of colleges or universities in NCR, Region III, and Region IV-A during the period of the competition.
- 2. Entrants must be capable of traveling to the festival venue in Metro Manila should his/her entry be chosen as a finalist of the Epson EcoVision Short Film Competition. However, the management will not shoulder any travel and accompanying costs for the finalists.
- 3. Relatives of employees from Epson Philippines Corporation (EPC) and Publicity, Relationship-Building and Communications, Incorporated (PRC, Inc.), up to second degree of consanguinity and affinity, are disqualified from joining the competition.

#### **Mechanics:**

All documentary entries must feature a Philippine-based organization or individual who champions or performs upcycling as a tool for environmental sustainability.

- 1. The documentary can be shot and edited using any device provided that the resolution is acceptable for cinematic viewing (at least 1080p).
- 2. Entries must have a minimum running time of 5 minutes to a maximum of 15 minutes. The running time should include the documentary title card provided by Epson Philippines (downloadable through <u>epson.com.ph/ecovision</u>) for the opening or closing credits.
- 3. English (US-standard) subtitles must be embedded in the final output.
- 4. Entries that have been exhibited in other competitions may be submitted and will be considered by the selection committee.





# Submission of Entries:

- 1. Entrants must fill out the submission form ("Form") which can be downloaded at: <u>epson.com.ph/ecovision</u>.
- 2. Entrants must upload a high-definition copy of their documentary (in MP4 format) via Google Drive to create a shareable link visible only to the owner of the film and the custodian of <u>epson.ecovision@gmail.com</u>.
- 3. All entries with accomplished Forms must be emailed to <u>epson.ecovision@gmail.com</u> with the subject: EcoVision - School *(ex. EcoVision - PUP)*
- 4. The e-mail entry should include the following attachments ("Submission of Entries"):
  - a. Completed Form (in PDF format)
  - b. A shareable and downloadable Google Drive link of the documentary entry and a 30-second trailer (MP4 format) copied in the body of the email
  - c. Scanned copy of the individual or group representative's student ID
  - d. Scanned copy of school's endorsement letter signed by the dean, department head, or the school head which bears the names of all production team members
- 5. By submitting the Form, you hereby agree that Epson Philippines may collect, obtain, store and process your personal data that you provide in this form for the purpose of receiving updates, news, promotional and marketing mails or materials pertaining to the Competition.

You hereby give your consent to Epson Philippines to:

- a. Store and process your Personal Data;
- b. Disclose your Personal Data to the relevant governmental authorities or third parties where required by law or for legal purposes.
- 6. Entries shall only be considered complete if all the items under *Submission of Entries* are received. Incomplete entries will not be considered.
- 7. The submission period is from **November 18, 2019** to **March 12, 2020** (until 11:59PM only). Late entries will be considered null and void.
- 8. Entrants shall receive a notification via email after 1-3 days to inform them if their submitted entry satisfies the submission requirements and qualifies for the competition.





### **Selection Process for the Finalists**

- 1. From all the entries, the Festival will shortlist the top 10 finalists to be included in the Competition's Official Selection on March 20, 2020, 6pm, after individual online scoring of the Selection Committee.
- 2. The Selection Committee, comprised of DENR-EMB-EEID and Epson representatives, will judge the submissions according to the following criteria:
  - a. **Adherence to the Theme (50pts)** How the documentary effectively depicts the chosen topic and how it clearly makes a connection between upcycling and environmental sustainability.
  - b. **Story/Content (40pts)** Overall excellence in storytelling, accuracy in information;
  - c. **Structure (10pts)** How the interview, images and music are arranged logically in a way that fits the purpose of the film
- 3. The Competition's Official Selection will be announced at Epson Philippines Corporation, 8/F, Anson's Centre, #23 ADB Ave. Ortigas Center Pasig City through Epson Philippines' official Facebook page (@EpsonPhilippines). The 10 finalists will also be notified via e-mail and a call from the Epson team on March 12, 2020.
- 4. Once the entry has officially been announced as part of the finalists for Epson EcoVision Short Film Competition, the entrant may then share it on any social media platform or in any way the entrant sees fit.
- 5. All finalists may only release their own announcements after Epson Philippines has made its own.
- 6. The finalists will also receive an E-mail from Epson Philippines providing an official approval to promote their videos. Finalists will also be invited during the Awards Night on March 26, 2020, where the winners for various awards will be announced.

#### Selection Process for the Final Judging and Awarding:

From the top ten (10) finalists, a new set of Board of Judges, composed of three members of the Selection Committee and a documentarist, will select three winners for the EcoVision Documentary Competition based on the following criteria:

- Adherence to the Theme (40pts) How the documentary showcased upcycling in relation to environmental sustainability
- **Story and Content (30pts)** Overall excellence in storytelling, measured by how well the documentary draws in the viewer and keeps his/her interest
- **Cinematic Attributes and Technical Execution (20pts)** Creative and technical approach in all departments including writing, directing, acting, editing, production design, cinematography, sound, and music.





• Aggregated number of Social Media engagements (10pts) – Total scores garnered in social media (Likes).

# **Computation Process of the Aggregated Social Media Engagements:**

1. The Finalists' trailers will be posted on Epson's official Facebook page to determine their scores for the social media engagement.

1 Like is equal to 1 point

- 2. The Social Media Engagements will be monitored starting from March 20, 2020 (12AM) to March 26, 2020 (11:59PM), only.

#### Prizes:

1. The winners of the competition will receive the following:

Champion	Php 80,000* cash prize and Epson products** worth P16,000 for the school
1st Runner Up	Php 40,000* cash prize and Epson products** worth P16,000 for the school
2nd Runner Up	Php 20,000* cash prize and Epson products** worth P16,000 for the school
Best Cinematography	Php10,000 and Plaque of Award
Best Film Editing	Php10,000 and Plaque of Award

# Claiming of Prizes:

- 1. All certificate of cash prizes and Epson products must be claimed personally by the winners or a representative during the Awards Night on March 26, 2020 (venue to be communicated to finalists). An Authorization Letter signed by the winner to authorize the representative shall be produced during the prize collection. If no such Authorization Letter is produced, EPC reserves the right not to allow any claim of the prizes.
- In the event that the winner or a representative cannot claim the certificate of cash prize on the Awards Night, the finalist must send a written notification to <u>ecovision@gmail.com</u> to notify Epson Philippines. Prizes may still be claimed personally at the Epson Philippines Corporation (EPC) office, 8th Floor, Anson's Center, 23 ADB Ave, Ortigas Center, Pasig, 1605 Metro Manila, until May 27, 2020.





3. Redemption of cash prizes is valid 60 days after the final judging and awarding of winners. The last date to claim the cash prizes is May 27, 2020. Any claim of cash prizes after May 27, 2020 shall not be entertained and such cash prizes shall be deemed to have been forfeited.

- 1. The Entrant owns the copyright of the original work created and is duly authorized to submit the documentary to the Epson EcoVision Short Film Competition Documentary Edition.
- 2. Epson Philippines hereby grants the Entrant a non-transferable and revocable license to use the Epson logo and the official EcoVision logo for the purposes of the documentary competition.
- 3. DENR-EMB-EEID hereby grants the Entrant to use the DENR logo for the purposes of the documentary competition.
- 4. If chosen as an Official Selection, the Entrant grants Epson Philippines, its parent company, subsidiaries, affiliates and associated companies ("its affiliates"), and DENR-EMB-EEID a royalty-free, worldwide, irrevocable, perpetual and non-exclusive license to screen the documentary with unlimited showings to showcase Epson's CSR efforts and for any related marketing initiatives on the ground or online; and to copy and use the documentary and documentary material (including stills or documentary segments) for non-commercial promotional purposes and for archival material, at no additional cost.
- 5. The Entrant represents and warrants that the submitted documentary and related documentary material do not infringe any intellectual property rights of third parties ("**IPR**"). The Entrant agrees to defend, indemnify and hold harmless Epson Philippines and its and affiliates and their respective directors, officers, shareholders, employees, against any and all actions, proceedings, liability, claim, damage, expenses (including court costs and legal fees on a full indemnity basis) or loss of whatever nature arising out of any third party claims for any alleged and/or actual infringement of any IPR which arises or would arise as a result of Epson EcoVision Documentary Competition's copy and use of the submitted documentary and related documentary material.
- 6. Epson Philippines will also not be liable for untoward incidents that may occur during the production of the documentary.
